**RESOLUTION NO. 2024-003**

**AT A MEETING OF THE BOARD OF THE CASSIA COUNTY COMMISSIONERS, HELD ON THE 16<sup>th</sup> DAY OF JANUARY, 2024, THE FOLLOWING RESOLUTION, REPEALING CASSIA COUNTY RESOLUTION NO 2002-11-1 IN ITS ENTIRETY REGARDING THE PROVISION OF NONMEDICAL SERVICES AND AMENDING RESOLUTION NO. 2012-022 REGARDING ADMINISTRATION OF THE DISPOSITION OF INDIGENT DECEASED IN CASSIA COUNTY, IDAHO.**

WHEREAS, the Board of Cassia County Commissioners is authorized, pursuant to Idaho Code Section 31-3401 to adopt resolutions, to promulgate policies and procedures, negotiate payments to providers, and contract for non-medical services; and

WHEREAS, the Board of Cassia County Commissioners has adopted Resolution No. 2012-022 regarding disposition of indigent deceased; and

WHEREAS, by act of the state legislature, Charity and Indigent Fund Levy was repealed by the State in its 2022 action on House Bill 735; and

WHEREAS, the County supports other institutions and entities in providing rent, food and other assistance to indigent persons; and

WHEREAS, without ability to levy for charitable or indigent persons, funding no longer exists to directly answer to such requests; and

WHEREAS, after review and consideration, minor amendments need to be made to Resolution No. 2012-022 regarding disposition of indigent deceased; and

WHEREAS, the Board of Commissioners having reviewed these matters, and have considered the Board's responsibilities as pertain hereto;


**NOW, THEREFORE, BE IT RESOLVED** that the Board of Cassia County Commissioners does hereby authorize the immediate repeal of the entirety of Cassia County Resolution No. 2002-11-1;

BE IT FURTHER RESOLVED that the Board of Cassia County Commissioners hereby amends Resolution No. 2012-022 as follows:

1. That section I.2. be repealed in its entirety.
2. That the amount of \$1,100 as the maximum rate be, and hereby is, raised to \$1,500.
