- 12) 9:16 AM VSO periodic update Chuck Driscoll
 - a) Mr. Driscoll presented a quarterly report. He noted asterisks on certain report numbers dealing with hours and military funerals and explained that in the past they had only been counting hours from one person. During one of their meetings, it was discussed that they should be giving credit for all of the hours donated and miles donated rather than just from one individual.
 - b) Mr. Driscoll was pleased to announce they now have a Veteran's Pantry which has been supplied mainly by other Veterans. He said they were able to keep up quite well with the needs of veterans and their families.
 - c) Commissioner Searle asked about medical coverage. Driscoll reported that coverage has diminished and relayed his own experience with the matter. Driscoll said the quality of the health care is as good as it ever was. He stated that the issue lies within the veterans' ability to pay the bills that come due and

- contributed the new fee structures and practices of turning veterans over to collection agencies rather than garnishing their social security to the current government administration.
- d) Commissioner Kunau was asked to work with Mr. Driscoll on sending a letter to Congressman Simpson's office regarding the matter if they don't get back with him in the next little while.
- e) Pat Field from the Republican Central Committee noted that the key-note speaker for the Lincoln Day Luncheon on Saturday will be Senator Mike Crapo. He also said that the Governor and Lt. Governor will also be in attendance.
- f) The Vietnam Veterans' Recognition dinner will be held 3/29/2023 at the Minidoka County Senior Center from 6:00 PM to 8:00 PM.

9:23 AM Prosecutor Larsen entered the meeting.9:26 AM Mr. McMurray entered the meeting.

- 13) 9:27 AM Schedule Tax Deed Hearing date and time for 2019 Delinquent Properties Treasurer
 - a) Treasurer Greener requested to set a date for a Tax Deed Hearing. This will allow her office to start the formal letters to those that still owe 2019 taxes.
 - b) There are still 108 parcels owned by 34 owners on the list. That number is up from last year at this time when there were 87 parcels with 30 owners. Some of the current parcels on the list have just been sold in the last week so those taxes should be brought to a current status soon.
 - c) It is likely that this tax deed hearing will be cancelled if the Treasurer can get every owner to bring their taxes current. Cassia County has not had a tax deed hearing in three years due to those efforts.
 - d) Tax Deed hearing was scheduled for 5/22/2023 at 9:30 AM.
- 14) 9:32 AM Review & approve Idaho Dept of Parks & Recreation Agreement re: Boat Safety Grant Taylor
 - a) This item was cancelled and will be put on the next week's agenda.
- 15) 9:57 AM Hearing on amendments to zoning ordinances, Ordinance 2023-01-01, amended

9:57 AM **Motion and Action:** Approve entering hearing on proposed amendments to zoning ordinances, Ordinance 2023-01-01, amended, **Moved by** Kent R. Searle - Member, **Seconded by** Bob Kunau - Member. Motion passed unanimously.

- a) Mr. McMurray first reviewed all of the amendments being proposed.
 - i) Appeals processes were being amended due to a case brought before the Planning and Zoning Commission in which there were two different sets of rules the case could fall under. For the sake of efficiency, the Commission decided to make one set of rules for both situations. Appeal rules set in Title 10 were being repealed and referred to rules set forth in Titles 9-5-6 and 9-5-7 for those processes.
 - ii) A case in Boundary County spawned the proposed changes to the zoning chart of uses being submitted. It involved Idaho Code Title 67-65-12. He said the Supreme Court stated that zoning administrators cannot make judgement calls with amendment processes. Those must go through the Board of County Commissioners. Mr. McMurray pointed out the sentence that seems to be causing concern in the proposed amendment, which states, "If it is not listed in these regulations, then it is not eligible for a permit." He reminded the Board that they can opt to remove that language if it is of concern to them.

- b) 10:21 AM Mr. Samuel Parry representing the Gibby Group. They are opposed to most of the language being put forth. They argue that the amendment changes give undue advantage to the county at the expense of the tax payers. He pointed out County Ordinance 9-3-3 which says that no amendment should be considered unless it promotes more fully the objectives and purposes of the zoning ordinance.
 - i) He stated opposition to the zoning chart and Mr. McMurray's interpretation of the case Gardner v. Boundary County. He contended the language of the ordinance in Boundary County allowed for any use even if it was not found on their chart which contradicted the Local Land Use Permit Act or "LLUPA". He said the chart was not supposed to be exhaustive of uses permitted by land owners. He said that in his letter they suggest language that could be used that also honors the Right to Farm Act and LLUPA.
 - ii) A second opposition was the appeal deadline being shortened as found in Title 10-3-4. He said the removal of deadlines allowed the County to respond indefinitely.
 - iii) Third was the surety options found in 10-4-6 and 10-5-6 removed all flexibility for developers and seemed unjustified. It removes all options for surety to only cash and increases the amount of surety from 125% to 150%. It benefits the County and not the tax payers, residents or applicants.
- c) Commissioner Beck made everyone aware that they are going to request a legal review of the case in question with Boundary County so that the Board is more educated on the issue.
- d) 10:29 AM Don Pickett Representing Pickett Ranch and Sheep Company. The letter submitted he said was on behalf of Southwest Irrigation rather than himself. He then submitted his own written testimony.
 - i) Mr. Pickett recited Idaho Code 42-201 (7), which delegates to the department of water resources exclusive authority over the appropriation of the public surface and ground waters of the state. No other agency, department, county, city, municipal corporation or other instrumentality or political subdivision of the state shall enact any rule or ordinance or take any other action to prohibit, restrict or regulate the appropriation of the public surface or ground waters of the state, and any such action shall be null and void. This was in response to the January 9th meeting in which Commissioner Beck stated the amendments were spawned from concerns about water in the County.
 - ii) He contended title 9-9-4I (7) and (8) were inconsistent with each other.
 - iii) Heart of concern is the chart found in 9-8-2. He requested the restrictive sentence previously pointed out be removed so as to allow for innovations in technologies and the creativity of farmers to achieve their goals in their pursuits.
 - iv) Brent Stoker and Randy Harris yielded 3 minutes each of their own time to help Mr. Pickett finish his testimony. Mr. Pickett read again Idaho Code 67-6529(1) No power granted hereby shall be construed to empower a board of county commissioners to enact any ordinance or resolution which deprives any owner of full and complete use of agricultural land for production of any agricultural product. Agricultural land shall be defined by local ordinance or resolution. He contended that the restrictive sentence found in the proposed amendment 9-8-2 is denying them full and complete use of their land. If there is an activity the Commissioners don't want to take place, simply list it on the chart and don't put a letter next to it.

- e) 10:40 AM Bart Thompson stated his biggest concern was a new dairy operation happening near his parents' place. He is concerned about the water usage and the natural springs found in the area are going to be contaminated. Other complaints brought forth were under the jurisdiction of either the City of Burley or Minidoka County.
- f) 10:44 AM Brent Stoker reiterated Mr. Pickett's concerns. He asked that the list be able to expand as technologies come about.
- g) 10:47 AM Randall Harris requested a constitutional analysis on any of the proposed changes. He argued the Planning & Zoning commission had no constitutional authority.
- h) 10:52 AM Tyson Nelson asked if a procedural error had occurred in that the amendments brought before the Board today had not been submitted to the Planning and Zoning Commission beforehand. Prosecutor Larsen stated 67-6509 (b) the Board had the authority to make decisions without the Planning and Zoning Commission's review. Mr. Nelson argued the notice was insufficient.

 - c) As a point of clarification, the point of the meeting on the 6th is for them to give a forecast of water availability this upcoming season and if they foresee any negative impacts for their patrons. The water advisory committee won't be formed until that point.

- d) Mr. Heida also informed the Board of Raft River district's interest in being on that committee. Part of the loan agreement they are receiving from the state says that they form an irrigation district so that will come before the Board in the next several months as well.
