

Cassia County Board of Commissioners SPECIAL MEETING MINUTES Monday, November 27, 2023 ACE Fire Protection District Office

The Cassia County Board of Commissioners met today at the place and time as posted by agenda pursuant to Idaho Code § 74-204 for Open Meetings Law.

AGENDA ITEMS

Roll Call.

Present: Leonard M. Beck - Chair, Kent R. Searle - Member, Bob Kunau - Member, Susan Keck - Deputy Clerk (Not voting).

- 4) 6:05 PM Community Meeting Question and Answers from the public in attendance
 - a) Commissioner Beck welcomed those in attendance and opened the meeting up for comments or questions from the community.
 - b) Bill Loughmiller stated that the roads are the biggest problem in the area and that he thought there were three alternatives that would fix them: 1) Divide the money differently in the county 2) Put Elba into the Raft River Highway District 3) Leave the rest of the money to Almo district or put into RRHD.
 - c) Harlan Ward commented that the issue was that better material was needed for the roads.
 - d) Commissioner Beck responded that the county already contributes to the Road and Bridge budget and that Ryan (County Road and Bridge Supervisor) put in @\$70,000 in the budget for gravel and that they are looking for better quality gravel. Beck also responded that the RRHD had already been approached to annex this area into their district, and they did not want to do that.
 - e) Paula Nelson from Elba commented on the bad conditions of the roads, stating that the bus struggled to get down the roads in wet conditions and that the families had to drive their kids to a bus stop.
 - f) Rick Olofson commented that there had been several months that the roads were impassible for 2WD vehicles, with mud and bad ruts, and mentioned that he took a fall when trying to walk across to his mailbox.
 - g) General discussion then occurred regarding the amount and poor quality of the gravel for the roads, with comments made from Mike Ottley, RB Higgins, Paula Nelson, Ryan and Beck, about options such as digging out the road and rebuilding with a better base and quality of gravel, purchasing better gravel from the Malta State Highway Dept pit, and possibly budgeting for crushing and/or screening equipment. Many comments were made in appreciation for Ryan and all of his efforts.
 - h) 6:38 PM Sara Jane Ward talked about the upcoming Republican Presidential Preference Primary, stating that it would be held on Saturday, Mar 2, 2024 in Almo at the ACE Fire Station and in Elba at the community building. She mentioned that voters would have to be affiliated with the Republican Party no later than Dec 29th in order to participate in the caucus and that it would be held from 12-2 PM.
