Both expressed concerns about traffic safety and potential problems they foresee in certain intersections.

- a) Mr. McMurray and Prosecutor Larsen reviewed that the attorney for the City of Heyburn is requesting county support when he submits legislation to change the language that describes the southern boundary of Minidoka County with Cassia County.
- b) Minidoka County's language uses the phrase "center of the main channel of the Snake River" whereas Cassia County just says the center of the Snake River. There is an island that needs to be surveyed but the ambiguity of the language makes it difficult to ascertain the actual physical boundary and correct county domain of the land.
- c) Mr. Ross is only seeking for Minidoka's description to be modified to agree with Cassia's legal description. No actual transfer of land would be sought as it is commonly accepted that the island belongs in Minidoka County.
- d) Prosecutor Larsen accepted direction to draft a letter of support to be considered for the Board's approval and signature on 1/29/2024.

 - a) Prosecutor Larsen provided interpretation and direction for continuing the Board of Equalization where revisions to the Missed Roll were needing to be introduced. The Board would discuss changes to be made and authorize Assessor Adams to make those changes that they approved of and submit an updated roll for the Board's approval.
 - b) Deputy Clerk Velasquez administered the Oath of Witness to those involved in the hearing.
 - c) Changes to five parcels were discussed at length. New state software programming glitches contributed to the bulk of the errors discovered on these parcels. Office procedures to verify reports and remedies to the glitches were proposed to address any problems arising in the future.
 - d) The Board expressed great interest in receiving training and updates with regards to property assessments and Board of Equalization any time it is available. Deputy Auditor Ahlin advised them of several types of focused trainings available through IAC as well as the State of Idaho.
