- 7) 9:21 AM Approval of an alcohol catering permit request for Palace Events Center LLC (1 Day - Beer, Wine, Liquor)
- a) This was addressed later in the meeting, after Prosecutor Larsen obtained information on statute with regards to the hours being applied for on the application.
 - b) 11:52 AM Issue was revisited. Statute allows for a permit to go up to five consecutive days. The application is for 5:00 PM on 5/18/2024 to 12:59 AM on 5/19/2024.
 - c) Another concern was discussed about the conflict that may exist with the conditional use permit for the operation of the rodeo during those hours. McMurray believed it was two separate issues in that the CUP did not address the limitation of alcohol sales, just the operation of the rodeo past a certain time.

- 11) 9:27 AM Continue plans for a summer employee picnic including but not limited to location, time, food, and optional additional attendees
- a) Beck said he visited with Deputy Auditor Wallace about the rebate from county credit cards. There is an amount that can be used to fund the picnic.
 - b) Locations were discussed. They wanted to hold it close to the county offices but can't use the lodge hall anymore as it is planned for demolition. The city park next door was suggested as it has been used in the past.
 - c) The item will be kept on the agenda for further discussions.
- 12) 12:00 PM Historical Society request to purchase railroad car wheels
- a) Kunau requested this be held until he receives word. No invoice has been received yet.
 - b) 1:57 PM Matter to be on the agenda again for next week.
- 13) 12:01 PM Review and approve Zwygart John & Associates Engagement Letter for the FY2024 Independent and Federal Single Audits
- a) The fee for the independent audit will be \$22,000.00 and the Federal Single Audit will be \$5,000.00.

- 14) 12:03 PM Discuss how to move forward on implementation of the Agriculture Protection Areas Act (H.B. 608)
- a) Legislature passed this bill and it takes effect 7/1/2024. The purpose of the bill was to provide an opportunity for those that own agricultural lands to put them into an agriculture protection area. It will become Title 67, Chapter 97.
 - b) The lands would carry that designation for 20 years and could be renewed. The lands could be removed from the protection designation after 10 years or under specified conditions of hardship.
 - c) The bill requires the County to have an ordinance in place by 1/1/2025 about how the county is going to deal with these designated lands, how protection areas will be determined, and have an Agriculture Protection Area Commission appointed.
 - d) The commission must consist of three to five members and the bill discusses the areas of expertise which should be included when considering who to appoint. The responsibilities outlined in the bill for commission members are also time-sensitive to comply with its mandatory January 1st deadline when taking into account irrigation season and harvest season.
 - e) The process of applying for a protection designation was discussed. It was pointed out that the protection of the lands could limit the freedoms of the property owner in some situations and possibly hinder economic benefit to them if not carefully considered.
 - f) It was discussed that the ordinance to be crafted was outside of Planning & Zoning Commissioner's purview and needed input from the commission to be appointed and the agriculture community for the Board of County Commissioners to hear.

15) 9:30 AM Approval of amendment to 2020 Subrecipient Agreement for HMGP 4313 Cassia County Oakley Dam, DR-4313-ID-05

- a) David Shirley representing the Goose Creek Flood Control District presented an amendment to the 2020 Subrecipient Grant being sought for improvements on the Oakley Dam relating to damage sustained by flooding in 2017.
- b) The original design that had been engineered and approved for grant money ended up being too expensive. Since they revamped the design and changed the scope of work, the application process had to be done again.
- c) The new two-valve design had been approved by FEMA. The new scope includes an air vent system, the installation of a liner coating on the inside of a tunnel and an enclosure to be built around the new valve system. They will also need to build a plunge pool as part of the system.
- d) The amount sought for in the grant has not increased. The Oakley Canal Company will increase their match award amount to cover the additional construction costs of the plunge pool and enclosure.
- e) They will also be submitting an extension of time request and tie it to two other projects happening in the county in order to get the time allowed since they cannot perform some of the work until the tunnel is empty. They hope to finish the project next spring.
- f) Shirley detailed his understanding of the new two-valve system they have proposed. It answers the safety concerns and need for redundancy in the system as well as preventing future damage due to cavitation from a single valve. It will allow the dam to release more water faster in an emergency.
- g) There isn't any change in the liability to the county from what was previously agreed upon in the first grant.

16) 9:51 AM Review and approve Federal Drug Testing Contract - Prewitt

- a) Prewitt presented the annual renewal contract that the County has been doing for the last four years, providing services for all of federal probation and parole groups in Southern Idaho.
- b) They don't perform the tests. They just collect the samples and ship them to another facility for testing. The county is paid \$10.00 for every sample collected. There are currently 14 individuals that come in.
- c) Her office is slated to perform regular drug tests for about 1,876 males and 675 females in the current month.

17) 9:56 AM South Central Public Health (SCPHD) annual budget proposal presentation

- a) Commissioner Hall from Twin Falls, as chairman of the board for SCPHD, made introductions. He said the proposal includes a 4% increase for employees and a 1% increase in what they ask from the counties.

- b) District Director Melody Bowyer presented the annual budget proposal. The public hearing for their FY2025 budget will be held in conjunction with their regular meeting, 5/15/2024, at 1:00 PM at their Twin Falls office. The Health Heroes Awards ceremony will be held on the same day at 11:30 AM.
- c) A proxy vote authorization form was included with the proposal documentation should another commissioner need to attend in Chairman Beck's stead.
- d) Also present for questions were Fiscal Officer Jeremy St. Clair, Health Educator Eli Thompson, Epidemiology Manager Tanis Maxwell, Environmental Health & Preparedness Director Josh Jensen, Family & Children's Health Division Administrator Logan Hudson, and Regional Environmental Health Specialist Scott Arnell.
- e) Ms. Bowyer reviewed the FY2025 Proposed Budget, estimated revenue sources for the proposed budget and a county contribution allocation comparison table. They are asking for \$274,497.00 from Cassia County, which is an increase of \$4,697.00 over last year. The contributions are calculated at 70% population growth for the county and 30% property valuation for the county. The 1% increase in county fees is an average of the eight counties in the region. The population and valuation numbers are taken from the US Census Bureau and the State of Idaho Tax Commission.
- f) They received a public health infrastructure grant to provide for some key positions in public health infrastructure such as hiring an HR manager, a Workforce Development Specialist, and a Health Education and Outreach representative. They have also pared down other positions they don't expect to fill that were included as part of the pandemic coverage.
- g) Their current reserve fund is \$2 million that is not included with other outside dedicated funds. All of the public health districts as a whole receive about 20% of the total Idaho State Opioid Settlement funds through a formula set by the Attorney General's Office. The City of Burley is the only city she is aware of that has reallocated all of their city's portion of funds to the health district.
- h) Eli Thompson's position is completely funded by the Opioid Settlement monies. The monies are projected to continue for the next 17 years or so. They want to use some of the money coming this next year for mental health projects.
- i) 10:19 AM Thompson who works primarily in drug prevention, reviewed some programs and projects he has been involved with in schools and local medical offices.
- j) 10:22 AM Tanis Maxwell, program manager over infectious disease, spoke briefly on services provided by the health department for tuberculosis (TB). Idaho had about 15 cases of TB in 2023, four of which were in our region and two of those in Cassia County. This year so far, our region has seen two cases of TB, one of which is in Cassia County.
- k) 10:27 AM Scott Arnell mentioned two things the commissioners will be seeing more of in the near future. The first is the increasing number of food trucks in the area is expected to double in the next couple years. He explained that when financial times are hard, mobile food units are one of the easiest businesses to enter with very little capital to make money for the family. All of the current food units they are aware of have been inspected and meet minimum health requirements.
- l) The second is in actual land development. He estimated approximately 150-175 recently platted lots in the county but only expects the high-end lots such as out on Frenchman's Island to be developed right now due to current interest rates.

- a) Assessor Adams stated for the record that exemptions have not been handled in the past as they should have been. Some parcels were granted an exemption in perpetuity even though code stated they require an annual application. He is correcting the process to align with Idaho code.
- b) The first group of applications were for churches and nonprofit organizations. Of the 23 organizations that received exemptions last year, all but three have responded with the needed documentation. The Assessor's Office has gone to great lengths to contact the other three and Adams believes he will get the needed documents from them if given a little more time.
- c) The deadline to approve or deny the applications is 5/15/2024.

- i) Rebecca Taylor, an attorney for IHC, appeared via Zoom to explain the hospital's application. They have requested 100% exemption for parcel RPBKP01001002A (Spring Creek Women's Health Clinic) and 97% exemption for parcel RP10S23E216158 (main hospital) based on square footage being leased to other entities within the hospital building.
- j) Life Flight which is based at the airport is also exempt but that is the City's jurisdiction.
- k) Adams will need to develop an accurate valuation of the hospital property in order to assess the remaining 3% that is not eligible for tax exemption before assessments are sent out. This has not been done before with the previous administration.
- l) The Board was interested to learn how urgent care facilities differ from the hospital for tax exemption status. The hospital application will be addressed next week after Adams has obtained more information on their questions.
- m) Adams reviewed the final group of applications which were land developers. According to IC63-602W these lands are considered inventory until they are developed and are granted an exemption of 75% of value annually until they've been built on.

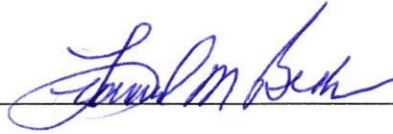

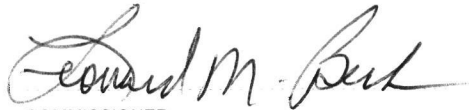
